Especially, since the job responsibilities of a police officer demand not only strong physical conditions, but also other abilities, such as education, adherence to the moral standards, and high-personal traits (tolerance, politeness, verbal/non-verbal communication skills, and deep respect to surrounding). Recent studies have shown a lot of positive outcomes from hiring the officers, who possess a college degree. At any rate, taking into consideration the long-simmering argument, a new study proves that police officers with some college education are less likely to apply physical force, than those without a college education. It is quite noticeable on a case-to-case basis that if the officer possesses more education, the likelihood of force application is much lower.



There are a few other indisputable reasons for the police officers to have taken a college program. Since the police officers have the responsibility to control the maintenance of the fundamental law among members of society, they should have complete knowledge of the laws and regulations on the state, and federal level as well. In such a manner, they would be better prepared to oversee the discipline in the community, and take immediate actions, in case of violence, according to the laws. Consequently, this is another example when it is highly recommended to go through the necessary classes or trainings that would teach the police officers such attributes as the code of ethics, and would provide officers with the necessary knowledge to apply on the job.

Inevitably, there are opponents to the idea of the schooling requirement of the police officers. They argue that being a police officer requires more skills than knowledge, and also the education part may not be available to everyone from the financial point of view. However, it is shown that there are more police officers, who represent minorities, and their performance is higher than of those without the education. The one fundamental evidence is that the police officers, who have a college degree, are less likely to abuse their authority. Thus, the education plays more of a moral training in some cases, and it becomes important for the society as well. The relevance of the moral education to the police officers, teaches them how to protect the community discreetly, and apply the psychological knowledge when needed. Thus, the notion of degree programs should also become useful along with the technical education and the



job training. A college degree also offers the ability to free the individual's mind, and thus, prepares police officers, who are more likely to deal with the potential situations that require psychological training, and could not be otherwise acquired only through a training program. A college degree could encourage a police officer to rethink the methods of applying their moral outlooks on a particular situation. All in all, the promoters of police education insist that a better-educated police officer will increase the positive outcomes of their work, and would lead to the creation of a more humane society.
